JOB SUMMARY: The <u>Youth Program Adult Mentor</u> reports directly to the Youth Programs Manager and leads, at minimum, one weekly L.O.U.D Youth group sessions and bi-weekly in person Parents/Caregivers of Trans Youth group. This position is meant to directly serve our L.O.U.D program and our Parents/Caregivers of Trans Youth group. We prioritize BIPOC, trans and non-binary adult mentors for our youth groups, L.O.U.D and Trans Tween. All groups meet online and/or in-person. The facilitator's role is to serve as a trusted adult mentor, create engaging group curriculum, plan group events/outings, and facilitate demographic data acquisition and reporting. This role will work in partnership with other mentors and Pacific Center staff support to provide a container for the emotional and mental health needs of group participants.

The role is also expected to engage in outreach with Alameda County schools, universities, and community organizations to create partnerships for referral and connection. When not facilitating, this role will spend their time creating connections, making visits to community spaces, and cultivating relationships. Personal transportation is not required.
